Airport Report – Lyle Honess noted that the Airport finances had improved from last year. Flights were up and expenses were down. Art Madore, is drafting a budget for 2016 and there will be a budget meeting in January or February. Lyle felt there should be more communications regarding the work to be done with the Commission members to have everyone's input into cost effective approaches for projects. There are going to be some major expense items coming up that include the replacement of the large fuel tanks, air guidance lighting and repairs to the building. Because the airport is has a grade one class, there are some expenses, due to line painting having to be done every two years, costing over 10,000 dollars.

Manitoulin Municipal Association - Arthur Hayden reported that Al Spacek the FONOM President was energetic, enthusiastic and interested in all problems or concerns the Manitoulin Municipalities were dealing with. He was in tune with issues of Northern Ontario and was sincere in his approach to the various topics discussed.

Manitoulin Planning Board - Ken Noland gave a review of the proposed project to have a fly over Manitoulin for aerial photography of the area. Council was all in agreement to support the project.

Provincial Offences Act – P.A. Palonen noted that the small profit of 10,000 dollars was to be split and 3,000 was to be put into reserves with the remaining 7,000 to be either used to offset the 2016 budget or to be returned to the member municipalities.

Policing (CPAC) - Wayne Bailey reported that the new incident report form was to be reviewed and he would have an opportunity to make comments on it. The new report is beneficial in providing an overview of the Island and an overview of our Municipality. The new report does not provide as much detailed information regarding incidents within the municipality.

Recreation - Wayne Bailey noted that he had been approached to see about holding an event that would include a Stompin Tom Connors tribute band. After consideration, it was decided that a larger venue would provide the necessary revenue to cover the costs. The annual Meet and Greet is to be held in February and there is to be an upcoming fundraising event of dinner and a dance for the C.C. McLean grade eight class.

Golden Age Club – Wayne Bailey reported that a group had attended the Golden Age Club to provide information about the Angel Bus. The group was very informative and the Golden Age Club donated \$1,000.00 to the bus.

Library - Wayne Bailey reported that both the vacuum and photo copier have quit working. The plan is to replace the vacuum but they were debating about replacing the photo copier. It was felt that the photo copier was being used for a lot more than copying things from the Library and it would be competing with local business.

Waste Management - P.A. Palonen is to have a meeting in January and noted that he had done a report previously on the status of the site however nothing had been done about it and he was interested in seeing to this at the meeting.

Ministry of Natural Resources and Forestry - Wayne Bailey presented a draft letter to the MNFR Honourable Minister Bill Mauro regarding the Municipality's loss of its tax base with the Nature Conservancy's purchase of large tracts of land and applying to have the property become classified as tax exempt. The Municipality would like to see more scientific research reports on these proposed properties and that they receive compensation for this loss tax revenue.

Building System Meeting - P.A. Palonen noted that there was to be another meeting regarding a new system for paying the Chief Building Official.
