Council could not find a compelling reason to move the pager. A discussion regarding the older fire truck resulted and Council will start looking into a new second hand truck.

Gore Bay Union Library - Wayne L. Bailey noted the summer student had been hired and she was to be from Evansville.

Waste Management - P.A. Palonen has informed the MPP Michael Mantha about his idea to have someone melt plastic to use as fuel. Council will delay discussions regarding a plastic processor to see if someone might be interested in starting a business to melt the plastics to be used for fuel.
